

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.taxrom.com and TAXROM INC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to TAXROM INC include www.taxrom.com and TAXROM. The TAXROM website is a provider of Services of Income Tax Returns Preparation for individuals ,in compliance with the USA Tax Authority, the IRS (Internal Revenue Services) rules and regulations. site. By using the TAXROM website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site.
